Adult General Education leads to a Secondary School Diploma (SSD) or the acquisition of prerequisites to access another type or level of training.

Social integration training does not lead to a diploma, but prepares adults experiencing social adjustment difficulties to transfer their learning to everyday life situations.

Socio-vocational integration offers short and medium-term programs leading to a local attestation and the labour market.

Vocation training leads to a diploma of vocational studies (DVS) or an attestation of vocational specialization (AVS) from the Ministry of Education to work in a particular trade.
